





When Your Loss Is Your Last Child

"This was a waste. I did this for nothing. I'll never get another chance." I'm ashamed to admit these were some of my first thoughts after being told our little son Jonathan no longer had a heartbeat. Yet deep down I convinced myself that someday I would somehow get another chance.

Shortly after my husband Byron and I were married, I was diagnosed with a kidney disease and was told I would eventually need a kidney transplant. At that time we were further advised to absolutely not get pregnant, which was fine with us because we were newlyweds, not yet ready to be parents, and Byron was still in dental school. Two years later as Byron's graduation drew near, the desire to start a family increased. My doctors consented to allow us to attempt a pregnancy but first detailed all the complications that I should prepare for. As soon as we were given the green light, just one month passed before we had good news to announce. Despite a few bumps during my last trimester, we delivered a healthy baby boy, Byron, Jr., in November 1991.

Just after our son turned three years old, I expressed to my doctors that we wanted to give Byron, Jr., a sibling. My kidney specialist was a little more hesitant this time because my kidneys had deteriorated since my first pregnancy. However, he felt with careful watch, I would in all likelihood be okay. He reminded me of the potential risks, and just like the first time, a month later we had good news to share. However, the bumps started much earlier this time with a continual elevation of my blood pressure and the constant, gradual decrease of kidney function. Five months into the pregnancy I was put on bed rest and eventually admitted into the hospital for round-theclock observation.

I celebrated each new day I had with my baby growing safely inside me. I knew every extra day he had to develop in my womb was vital to his health and development. The idea that he could die NEVER entered my mind. He was my miracle baby, my precious gift from God (which is what the name Jonathan means), and I was certain the Lord had predestined his life for something great.

However, on June 24, 1995, little Jon-Jon went to be with Jesus while still snuggled in my womb. He managed to become completely entangled in the umbilical cord. Upon delivery the cord was unwrapped from his head, body, and left leg. His death had nothing to do with the complications for which I was hospitalized. It was a freak accident, something that could not have been prepared for, prevented, or fixed. I could not believe I had risked my health and my life only for it to end with the death of my baby. Yet the thoughts of this being a waste did not last long, for I realized how much I truly loved my tiny son. He was not a waste. He was not for nothing. Even if I was never able to have another baby, I would not trade the seven months I had with him for anything.

Two years after losing Jonathan, I went into kidney failure and qualified for the transplant list. At that time $M = N \square$ was just a few months old, I was still grieving for Jonathan, and I very much wanted another baby. I honestly did not consider a transplant as something that would keep me off dialysis and save my life. Instead I thought of it as an infertility treatment of sorts. I had been told that after a successful transplant I could possibly attempt another pregnancy, so that was my goal. It was my light at the end of a very dark tunnel. One by one members of my family began the testing process to see if they were a match to donate one of their kidneys to me, and one by one they were declined due to tissue incompatibility. After we exhausted the list of eligible family members, my pastor and his wife volunteered to be tested, but they, too, were rejected for the same reason. Then their daughter and her husband offered to be tested as well, and to our surprise, she was a match. Nearly five years after Jonathan's stillbirth, on February 16, 2000, my friend Valerie Jones donated one of her kidneys to me.

A year and a half later, my nephrologist recited the list of risks to me for the third time, and just like before, within a month we joyfully announced we were again expecting a baby. I was cautiously excited this time, afraid to get too attached, but felt sure this would be the happily ever after to our story. However, ten weeks into that pregnancy a sonogram sadly revealed our little baby had peacefully slipped away to Heaven. Just before Christmas 2001, I had a D&C to remove its lifeless body from me. I developed a serious infection, had to have a repeat emergency surgery a few days later, and spent two nights on the transplant floor with triple IV antibiotics.

After this, my obstetrician was willing to help us try again, but my nephrologists were discouraging it. I prayed and prayed about it but never felt a peace about going forward with a fourth pregnancy. I was obsessed with having another baby but deep down felt it was not the right thing to do. I had a husband and son who needed me. What if some of the major risks of my becoming pregnant again really happened? Was it more unfair for our son to be an only child, or for him to have a mother that was on dialysis several times a week because I had lost my transplanted kidney, or was impaired due to a stroke? Worse yet, what if the risks of another pregnancy brought about my death and left my son without a mother?

I am often asked how and when I decided not to try again. I can't really say I did decide. I spent many months praying for God to take the yearning away if it was not part of His plan for us to have another child. It just never felt "right" to do again, and over time the longing faded. I truly consider this as a testimony, because the desire to have another baby was so great I could not have possibly made it go away on my own. The Lord gave me a peace and sense of contentment for our family to just be the three of us. I will always be sad we couldn't have any more children, but I'm no longer sad we can't.

"...I've learned by now to be quite content whatever my circumstances. I'm just as happy with little as with much, with much as with little. I've found the recipe for being happy whether full or hungry, hands full or hands empty. Whatever I have, wherever I am, I can make it through anything in the One who makes me who I am." Holding a Place

A Study by Debbie Amentrout

I have been in neonatal nursing since 1975. Over the years I have functioned as a staff nurse, clinical nurse specialist, transport nurse, and a nurse practitioner. In 2001, I enrolled in a local doctoral program. For my area of research I choose to do a grounded theory study of parents who had to make the decision to remove their infant from life support and how they moved forward with their lives. In 2004, I had the privilege of interviewing 15 members of M = ND as my study participants. This article is a synopsis of my results, partially taken from my dissertation article published in the electronic pages of the March 2007, issue of Newborn and Infant Nursing Reviews.

Holding a Place: Parents Bringing Their Infant Forward in Their Daily Lives Following the Removal of Life Support and Subsequent Infant Death

During the interviews a prelude to the core theory emerged in which the parents vocalized a common belief that, compared to other types of losses people experience, their situations of having lost an infant were unique. Four content areas explaining the uniqueness of their perinatal losses were identified: 1) residual trauma associated with having had a sick neonate in the newborn intensive care unit (NICU); 2) how differences in loss type give rise to differences in grieving; 3) their membership in a subgroup of parents who removed life support from their infants; and, 4) the brevity of the infant's life. These content areas provide the backdrop that guided the interpretation and presentation of how these parents moved forward following the death of their infant.

The NICU: Residual Trauma

In telling their infant's story, participants invariably commented on the emotional turmoil they endured while their infant was hospitalized in the NICU. Parents still vividly recalled their lives in the NICU as a series of "high highs and low lows" as they waited and watched at their infant's bedside.

A first time father of twin girls born at 25 weeks gestation, expressed an ongoing inability to fully comprehend how his daughter's hold on life changed so dramatically:

"Why all of a sudden...yesterday everything was fine and today it was just going downhill. That's what I don't understand...how for the first three days she was able to do...and then all of a sudden she doesn't."

One mother described life, death, and grief experiences in the NICU as turbulent and likens her NICU experience of 12 years ago to current views of post-traumatic stress:

"The aftermath of life and death in the NICU has complications...that kind of add to the grief, but currently it's kind of like all lumped together; when you have done the life and death in the NICU experience there is a post-traumatic stress quality to your grief that is different from families who have had other kinds of [grief]...who have had less turbulent death experiences. For us it was he's going to live, he's going to die, he's going to live, he's going to die...I had a very complicated grief, and I think that a lot of it had to do with recovering not only from his death but recovering from what we went through while he was alive."

These excerpts displayed above are representative of the sample's descriptions of lives thrust not only into the foreign world of the NICU in which "you walk into the room and you look for the baby amongst all the equipment" and "where you don't know what's going to happen" but also in a life and death situation with their infant where death was to be the eventual outcome.

A Loss that is Different from All Others

Parents commented that, while grief due to any form of loss has some common features, the grief they experienced during and after the loss of their infants so soon after birth had a uniqueness unto itself. One parent said:

"We went to a grief class...one...near at our church...and it was kind of like for all grief...one lady had lost a son, but he was 35 years old when she lost him. Completely different than 12 days. You might have been with a spouse for 50 years and lost him. I mean, there's a lot of similarity in grief but there's something completely different about losing a young child."

The differences in grief experiences between other forms of loss and that of perinatal loss are illustrated in the following excerpts:





"I've had people say 'Oh I lost a baby, I had a miscarriage at eight weeks' and I'm thinking I'm sorry, but it's not the same thing...I never had a miscarriage so I'm not going to demean anybody who feels that way...but I just can't imagine it's the same, and you're right, it's often grouped together...because she was so young I get grouped with that a lot and I say No, No...that's why it's important for me and for others to see her picture...Now that you see her, you tell me that's the same as an eight-week miscarriage."

Another explained:

"All of our baby deaths are different...I guess the common link would be...uhm...SIDS – they, they could all relate together; a miscarriage, all together...in situations where it's so rare...it's hard...to connect with that kind of person...I can only imagine what a grieving mother feels about SIDS. Just like that mom...can relate to me but doesn't know what I went through when I felt that explosion in my stomach knowing...I'm going into an emergency situation, waking up to being told she has to be gone...every situation is different."

These excerpts richly inform the basis upon which participants viewed their grief and loss as unique from other forms of grief and loss.

Membership in a Special Subgroup of Parents

Many participants found participation in parent loss support groups to be beneficial; however, even with shared experiences and support from other couples that had experienced a newborn loss, feeling a part of these groups of parents was very difficult. The study parents felt isolated in their grief as was explained by a mother of four previous children with a surviving twin sibling to the daughter born with lethal congenital defects when she stated "I feel sort of isolated" and revealed that she does "not [often] have the opportunity to talk with [other] parents that have had babies on life support and had to remove them." This sentiment was echoed by the mother of a daughter with congenital heart disease who said, "This is not something that you normally hear [from most other parents]...people who have had similar experiences taking them off life support." Whereas none of the parents expressed "regret" over their decision to remove life support, some of the parents commented that they would like the opportunity to discuss "doubts" they occasionally experience regarding some aspect of what was or was not done at the time of the decision-making with others having had to make that same horrific decision.

Brevity of the Infant's Life

Parents repeatedly expressed anger and hurt when family and friends would minimize their loss based on the infant's short length of life.

"The reality that there was a child and a life that came and went was ... seemed to have been lost on a lot of people."

"So those are things...not treating her as if she was a person that was here...is hurtful."

As one parent reported to family members who viewed a loss due to SIDS as a 'real loss' compared to the death of his 25-week daughter at three days of age:

"They said well, there's a difference between [a child that lived] a year compared to three days. No, it is not. I said we had our hopes and dreams shattered right before our eyes. Once you hold a child, regardless of their size, there's a lot of things going through your mind. You're thinking about for their future and all the fun times you're going to share as a family and all that stuff."

These powerful descriptions set the stage for the intense grief experienced by the study participants as they moved forward without having their deceased infants as a physical part of their ongoing worlds. Throughout this study, abstraction of the interviews led to the emergence of the core theory, *The Process of Holding a Place*, which describes the basic social process parents used to carry their deceased infant forward with them in their daily lives. This theory contains three thematic concepts and their sub-themes: 1) facing the decision (no real choice, time with the infant); 2) life goes on (listen to your heart, an abiding loss, not left out); and 3) lives forever changed (new perspectives, preparing to meet again). \blacktriangledown
